**Fund Manager****First Sentier – Multi-Asset Funds**

As Responsible Entity, Colonial First State (CFS) has made the decision to replace the First Sentier Multi-Asset Solutions team with the CFS Investments team led by Jonathan Armitage (CIO) and Al Clark (Head of Investments). The change is applicable for the following funds:

- First Sentier Wholesale Balanced Fund;
- First Sentier Wholesale Conservative Fund;
- First Sentier Wholesale Diversified Fund; and
- First Sentier Wholesale High Growth Fund.

The decision to replace the responsible persons for asset allocation of the fund was driven by the recent restructure to the First Sentier Multi-Asset Solutions team and the reduction in resourcing and capability of this team. The responsible entity determined this course of action is appropriate for investors as the funds will benefit from the scale and processes of the CFS Investments team which are currently responsible for managing over \$59bn in multi-asset and multi-manager products.

The CFS Investments team has deep knowledge of the underlying FSI strategies and believes there are no immediate changes to the existing underlying allocations. The CFS Investments team will incorporate these funds into the existing asset allocation process and review the asset allocation and manager selection to ensure the composition of the funds remain appropriate for investors.
